NOTICE OF PROPOSED AGENCY ACTION
ORDER APPROVING TRANSFER OF ASSETS AND CANCELLATION OF
INTEREXCHANGE TELECOMMUNICATIONS CERTIFICATE

BY THE COMMISSION:

NOTICE IS HEREBY GIVEN by the Florida Public Service Commission that the action discussed herein is preliminary in nature and will become final unless a person whose interests are substantially affected files a petition for a formal proceeding, pursuant to Rule 25-22.029, Florida Administrative Code.

Section 364.33, Florida Statutes, provides that a person may not acquire ownership or control of any telecommunications facility, or any extension thereof for the purpose of providing telecommunications services to the public, including the acquisition, transfer, or assignment of majority organizational control or controlling stock ownership, without pr or approval from this Commission.

National Collegiate, Inc. (National Collegiate) is the holder of Interexchange Telecommunications (IXC) Certificate No. 5627. Premiere Communications, Inc. (Premiere) is the holder of IXC Certificate No. 2958. By letter dated August 6, 1998, National Collegiate and Premiere filed with this Commission a joint petition for approval of transfer of assets of National Collegiate to Premiere. Further, National Collegiate has requested the cancellation of its IXC Certificate No. 5627.

We determine that National Collegiate and Premiere have met the requirements of Section 364.33, Florida Statutes. Accordingly, we find that the transfer of assets of National Collegiate to Premiere is in the public interest, and we approve it pursuant to Section 364.33, Florida Statutes.

National Collegiate has complied with the provision of Rule 25-24.474(2), Florida Administrative Code, by providing adequate notice in writing of its request for cancellation of its IXC certificate and by submitting its regulatory assessment fees for 1997. Accordingly, we find it appropriate to cancel IXC Certificate No. 5627.

National Collegiate shall return its certificate to this Commission. In addition, under Section 364.336, Florida Statutes, certificate holders must pay a minimum annual regulatory assessment fee of \$50 if the certificate was active during any portion of the calendar year. A Regulatory Assessment Fee Return notice for 1998 will be mailed to National Collegiate. Neither the cancellation of its certificate nor the failure to receive a Regulatory Assessment Fee Return notice for 1998 shall relieve National Collegiate from its obligation to pay due and owing regulatory assessment fees.

Based on the foregoing, it is,

ORDERED by the Florida Public Service Commission that the transfer of assets of National Collegiate, Inc. to Premiere Communications, Inc. is hereby approved. It is further

ORDERED that National Collegiate, Inc.'s Certificate No. 5627 to provide Interexchange Telecommunications services is hereby cancelled. It is further

ORDERED that National Collegiate, Inc. shall return its certificate to this Commission and remit all due and owing regulatory assessment fees for 1998. It is further

NOTICE OF FURTHER PROCEEDINGS OR JUDICIAL REVIEW

The Florida Public Service Commission is required by Section 120.569(1), Florida Statutes, to notify parties of any administrative hearing or judicial review of Commission orders that is available under Sections 120.57 or 120.68, Florida Statutes, as well as the procedures and time limits that apply. This notice should not be construed to mean all requests for an administrative hearing or judicial review will be granted or result in the relief sought.

Mediation may be available on a case-by-case basis. If mediation is conducted, it does not affect a substantially interested person's right to a hearing.

The action proposed herein is preliminary in nature. Any person whose substantial interests are affected by the action proposed by this order may file a petition for a formal proceeding, in the form provided by Rule 28-106.201, Florida Administrative Code. This petition must be received by the Director, Division of Records and Reporting, 2540 Shumard Oak Boulevard, Tallahassee, Florida 32399-0850, by the close of business on November 12, 1998.

In the absence of such a petition, this order shall become effective on the day subsequent to the above date.

Any objection or protest filed in this docket before the issuance date of this order is considered abandoned unless it satisfies the foregoing conditions and is renewed within the specified protest period.

If this order becomes final and effective on the date described above, any party substantially affected may request judicial review by the Florida Supreme Court in the case of an electric, gas or telephone utility or by the First District Court of Appeal in the case of a water or wastewater utility by filing a notice of appeal with the Director, Division of Records and Reporting and filing a copy of the notice of appeal and the filing fee with the appropriate court. This filing must be completed within thirty (30) days of the effective date of this order, pursuant to Rule 9.110, Florida Rules of Appellate Procedure. The notice of appeal must be in the form specified in Rule 9.900(a), Florida Rules of Appellate Procedure.
