This acknowledges receipt of a certified request for letter of release to place the subject water main into service [DEP Form 62-555.910(9)] and supportive documentation on March 17, 1997. This project was approved for construction under the permit application tracking system (PATS) number described above, issued June 27, 1996.

Your engineer of record has certified that the subject facilities have been completed to the extent noted on signed and sealed February 28, 1997 "record drawings". These facilities were cleared bacteriologically in accordance with Rule 62-555.345 Florida Administrative Code with submission of satisfactory results for samples collected on February 17 and 18, 1997.

Based on this information, we are issuing this letter of release to place into service the water main for the subject facility.
