PURPOSE AND PROCEDURE

The purpose of this hearing shall be to receive testimony and exhibits relative to the following: (1) Determination of the Projected Energy Conservation Cost Recovery (ECCR) Factors for the period April, 1999, through December, 1999, and (2) Determination of the Final Conservation True-Up Amounts for the period October, 1997, through March, 1998, which are based on actual data for that period. The Commission may hear any motions or other matters that may be pending at the time of the hearing and may rule on any such motions from the bench or may take the matters under advisement.

At the hearing, all parties shall be given the opportunity to present testimony and other evidence on the issues identified by the parties at the prehearing conference held on January 27, 1999. All witnesses shall be subject to cross-examination at the conclusion of their testimony.
