B. The City of Longwood shall answer these interrogatories to the fullest extent possible and shall furnish all information which is reasonably available to the City of Longwood, its principals, agents, attorneys, affiliates or other representatives.

C. If the City of Longwood cannot answer a particular interrogatory in full, after exercising due diligence to secure the information to do so, it should state the answer to the extent possible and specify why it is unable to answer the remainder. In addition, the City of Longwood shall state whatever information or knowledge that it has concerning the unanswered portion.

D. If the requested information is not applicable, that response should be reported as well as the reason why. If the requested information is not available, that response should be reported as well as the reason why.

E. Please report the name(s) of each person responding to each of the following interrogatories, the business address and telephone number of each such person, and the relationship of each person to the City of Longwood. Also, identify which interrogatory each such person has answered.

1. Please discuss whether the City of Longwood's wastewater treatment plant is in compliance with all rules and regulations of the Department of Environmental Protection.

Yes. The City of Longwood is a wholesale customer of Seminole County Environmental Services. All wastewater within the City service area is treated by Seminole County. To the best of our knowledge and belief Seminole County is in compliance with all rules and regulations of the Department of Environmental Protection.

The City of Longwood, through Seminole County, has a total capacity of 1.2 mgD available. Currently there is 464,000 gallons per day on line, 38,946 GPD reserved for projects not yet on line, 15,471 gallons per day reserved and uncommitted and the remainder available for purchase as per our agreement with Seminole County.

9. Please discuss whether the City of Longwood provides wastewater reuse. If so, please discuss where and to how many customers.

No reuse is available.

10. If the City of Longwood provides wastewater reuse, please discuss whether the area near the proposed area would receive wastewater reuse service.

11. According to Exhibit A of the application by Florida Water Service Corporation (FWSC) states, "Prior to 1994, the City of Longwood requested that Florida Water Services include the proposed service area into its certificated area." Please explain or clarify the history behind that statement.

The City of Longwood has researched its records and there is no written documentation that the City of Longwood requested or granted permission to Florida Water Service to include the proposed service area into its certificated area. Florida Water Services has stated on several occasions that it has a letter or other written documentation concerning this statement. However, Florida Water Services has failed to produce said letter or written documentation despite numerous requests by the City of Longwood.

Upon investigation the City of Longwood has determined that prior to 1994 a representative of Southern States Utilities (the owner of the subject service area at that time) approached the City of Longwood and asked if the City of Longwood would be interested in having Southern States Utilities expand its sewer service into the subject area. Although the subject area was and is in the City of Longwood Comprehensive Master Wastewater Collection Plan dated April, 1988, Rev. April 1989, the City of Longwood did not plan to expand into the subject area for a few years. Since there was a need for sewer service in the subject area the representative of the City indicated that the City of Longwood may look favorable upon such an application. Thereafter, there was no further communication and no formal request of the City of Longwood or to the Public Service Commission to expand the service into the subject area. It is now over five (5) years later and the City of Longwood is now ready, willing and able to expand its sewer service into the subject area. The City of Longwood has the engineering for the project budgeted for FYI 1998 - 1999 and continuation budgeted for 1999 - 2000. The City of Longwood may complete the expansion during the later half of 1999, subject to the outcome of this application.

The City of Longwood has already applied for the permission to run its sewer line under the CSX railroad track. Cost estimates are \$10,000.00 to complete the placement of sewer pipe under the CSX railroad track.

Please discuss whether the City of Longwood believes that the amendment application is in compliance with the Seminole County Comprehensive Plan, and explain specifically how it is or is not in compliance.

The City of Longwood does not believe that FWSC's application is in compliance with the wastewater section of the Seminole County Comprehensive Plan. The disputed area is within the City limits (boundaries) of the City of Longwood. The subject area is in compliance with the wastewater section of the City of Longwood Comprehensive Plan.

13. Please discuss whether the City of Longwood believes this amendment application is in compliance with the established local comprehensive plans developed pursuant to Florida Statute Section 163.3161 - 163.3211, and explain specifically how it is or is not in compliance.

The City of Longwood does not believe the amendment application is in compliance with the established local comprehensive plan developed pursuant to Florida Statute Section 163.316-163.3211. The local comprehensive plan clearly adopts the Comprehensive Master Wastewater Collection Plan, April 1988, Rev. April 1989. Said plan clearly provides for the City of Longwood to expand its wastewater service into the area contained in the amendment application. Therefore to grant the amendment application would not be consistent with the local comprehensive plan.
