Dear Mr. Deterding:

By this letter, Commission staff requests that Aloha Utilities, Inc. (Aloha or utility) please provide responses to the following data requests:

According to your letter dated November 25, 1998 to Blanca S. Bayo, the facilities or lines 2.04 ---relocated were placed in service in March of 1997. Cronin, Jackson, Nixon & Wilson, CPAs, PA. (CJNW) prepared a special report dated April 30, 1997, consisting of thirteen schedules. This special report by CJNW is Exhibit "A" of Aloha's application. Schedule No. 10 of this report is a schedule of the utility's calculation of allowance for funds used during construction (AFUDC).

Since the facilities or lines relocated were placed in service in March of 1997, please explain why Aloha continued the recognition of construction work in progress (instead of plant) and accrued AFUDC from April of 1997 to August of 1997. ÷

2. Regarding the utility's response to number 5(a) of Staff's First Data Request, Aloha stated it incurred a total of \$148,415.99 in engineering services. In the utility's original application, Aloha e p. L_₽. indicated that the Florida Department of Transportation (DOT) reimbursed the utility \$83,178.07)¥(of the \$128,573.14 in engineering services incurred through February of 1996, which equates to م الم DOCUMENT NUMBEI 64.69% of the \$128,573.14 figure.
