Issue 1: Should the Commission impose a \$500 fine or cancel the interexchange telecommunications certificates issued to each company listed on page 8 of staff's January 21, 1999 memorandum for apparent violation of Rule 25-4.0161, Florida Administrative Code, Regulatory Assessment Fees; Telecommunications Companies?

Recommendation: Yes. The Commission should impose a \$500 fine or cancel each company's certificate listed on page 8 of staff's memorandum if the fine and the regulatory assessment fees, including statutory penalties and interest, are not received by the Commission within five business days after the conclusion of the 21-day protest period. The fine should be paid to the Florida Public Service Commission and forwarded to the Office of the Comptroller for deposit in the State General Revenue Fund pursuant to Section 364.285(1), Florida Statutes. protested and the fine and regulatory assessment fees, including statutory penalties and interest, are not received, the interexchange telecommunications certificates listed on page 8 of staff's memorandum should be canceled with an effective date of December 31, 1998.

Issue 2: Should the Commission impose a \$500 fine or cancel the interexchange telecommunications certificates issued to each company listed on page 8 for apparent violation of Rule 25-24.480(2) (a) and (b), Florida Administrative Code, Records & Reports; Rules Incorporated?

Recommendation: Yes. The Commission should impose a \$500 fine or cancel the companies' respective certificates if the information required by Rule 25-24.480(2) (a) and (b), F.A.C. and fine are not received by the Commission within five business days after the conclusion of the 21-day protest period. The fine should be paid to the Florida Public Service Commission and forwarded to the Office of the Comptroller for deposit in the State General Revenue Fund pursuant to Section 364.285(1), Florida Statutes. If the Commission's order is not protested and the required information and fine are not received, the interexchange telecommunications certificates listed on page 8 should be canceled with an effective date of December 31, 1998.
