- 2 A. My name is Hugh W. Harling, Jr. and I am employed
- 3 by Harling, Locklin & Associates, Inc. ("Harling,

- 6 O. WHAT IS YOUR POSITION WITH HARLING LOCKLIN?
- 7 A. I am the President and owner of Harling Locklin.
- 8 Q. WHAT IS THE PURPOSE OF YOUR TESTIMONY?
- 9 A. The purpose of my testimony is to address a
- 10 concern expressed by the Public Service Commission
- 11 (PSC) Staff that developer interest in the
- 12 territory amendment Florida Water filed with the
- 13 Commission has not been clearly stated.
- 14 Q. HOW DO YOUR RESPONSIBILITIES AS PRESIDENT OF
- 15 HARLING LOCKLIN PERTAIN TO THIS MATTER BEFORE THE
- 16 **PSC?**
- 17 A. Harling Locklin are the planners, surveyors and
- 18 engineers authorized on this project for Mr. Carl
- 19 Rose. Mr. Rose owns Lots 4, 5 & 6 of Block Q and
- Lots 4, 5 & 6 of Block R, Section 28, Township 21,
- 21 Range 32 East, at the Southeast corner of CR 419
- and Lake Mills Road, Seminole County, Florida.
- 23 Approximately 5.6 acres of the property will be
- 24 a commercial site, and 7.74 acres of the property

will be half for the Florida Baptist Church School
and half for an assisted living facility. Mr.
Rose's property is located in the southern portion
of Florida Water's proposed territory. I am
authorized by Mr. Rose to represent his position
in this matter before the PSC.

Q. DOES MR. ROSE DESIRE FLORIDA WATER TO PROVIDE HIS 8 PROPERTY WITH WATER AND SEWER SERVICE?

Yes, as stated in the attached letter marked as Α. Exhibit (HH-1). In addition, Mr. Rose has requested two special exceptions on the 7.74 acres south of the commercial site to locate a Florida Baptist Affiliate School next to the First Baptist Church of Chuluota and a Florida Baptist Affiliate Assisted Living Facility (also adjacent to the First Baptist Church of Chuluota). Each of these projects will require water and sewer. The legal description for the school and assisted living facility is: Parcel ID No. 33-21-32-300-016A-0000: That portion of the northwest 1/4 of the northwest 1/4 of the northwest 1/4 of Section 33, Township 21 South, Range 32 East, Seminole County, Florida, less State Road 419 right-of-way, Less old SR 13 right-of-way, containing 7.74 acres more or less.
