Dear Mr. Ash:

During a phone conversation with you around March 9, 1999, you addressed concerns about your meter having been broken and under water. You also stated that the meter could not be read and that you had been billed estimated usage of 5,000 gallons for some months. You stated that your average usage is 3,000 gallons per month.

We requested billed water usage for the most recent 12-month to include the meter reading through the date the new meter was replaced by the utility, Lindrick Service Corporation. The utility submitted billed usage for 15-months prior to the new meter installation (see attached). Based on this information you were billed for 42,000 gallons of water for the 15-month time frame. The average billed usage is 2,800 gallons which is in line with the 3,000 gallons average you mentioned. Therefore, it appears that your billed usage was not overstated.

Attached is the readings and usages for the above mentioned address. We have included a 15-month period to show his usages and the ones that were estimated.

The majority of times (with water in box) water comes from sprinklers or rain filling the box. We watch these areas for a couple of months. If this water continues to stay, we send our serviceman to repair a leak or replace the meter.

In looking at our estimates on the period involved, we estimated one month with O consumption and then 2 months of 5,000 gallons each for a total of 10,000 gallons.

In calculating the cost/figures for estimated and adjusted billing, this is what we have:
