Thank you and your staff for keeping me well informed on this utility matter. I regret I am unable to attend the May 4 or May 18 meeting on this very important decision for our residents (myself included as a Lindrick customer). However my duties as Chairman of the Pasco County Commission keeps me here as our meetings are scheduled the same time as yours.

While I recognize that some rate increase will be necessary, may I suggest to you that the rate requested is very high. Also I ask that whatever rate increase is set that the amortization schedule not be as short as requested but rather extended so as not to be such a big hit to the rate payers all at once.

I am aware that certain funds will be necessary for the emergency repairs being made but not to the extent proposed.
