ORDER DENYING STAY AND EXTENDING TESTIMONY SCHEDULE

On May 27, 1999, a Joint Motion to Accept Stipulation and Voluntary Number Conservation Measures, Issue Temporary Stay, and Request for Expedited Ruling was filed. The Commission will consider the proposed stipulation at its June 29, 1999, agenda conference.

The Movants requested a stay of the hearing proceedings while the Commission considered the proposed stipulation. The Commission considers the issue of statewide emergency area code relief of great public importance. Moreover, the calendar will not accommodate new hearing dates for several months. Upon consideration, I find the hearing schedule will not be stayed until the Commission rules on the stipulation.

The Movants have devoted much time in the preparation of the stipulation and meeting with staff. Direct testimony and prehearing statements were due to be filed on June 4, 1999, pursuant to Order No. PSC-99-1012-PCO-TP. Because the amount of time the parties have to prepare their testimony and prehearing statements was reduced, I find that moving the filing date to Wednesday, June 9, 1999, is appropriate. The filing date for rebuttal testimony is moved to Friday, June 18, 1999. The parties should provide service by hand delivery or overnight mail to accommodate the short time schedule.

Based on the foregoing, it is

ORDERED by Commissioner Julia L. Johnson, as Prehearing Officer, that the request for stay of the proceeding is denied. It is further

ORDERED that all direct testimony and prehearing statements are due Wednesday, June 9, 1999, and rebuttal testimony is due Friday, June 18, 1999. Service will be by hand delivery or overnight mail.

NOTICE OF FURTHER PROCEEDINGS OR JUDICIAL REVIEW

Mediation may be available on a case-by-case basis. If mediation is conducted, it does not affect a substantially interested person's right to a hearing.

Any party adversely affected by this order, which is preliminary, procedural or intermediate in nature, may request: (1) reconsideration within 10 days pursuant to Rule 25-22.0376, Florida Administrative Code, if issued by a Prehearing Officer; (2) reconsideration within 15 days pursuant to Rule 25-22.060, Florida Administrative Code, if issued by the Commission; or (3) judicial review by the Florida Supreme Court, in the case of an electric, gas or telephone utility, or the First District Court of Appeal, in the case of a water or wastewater utility. A motion for reconsideration shall be filed with the Director, Division of Records and Reporting, in the form prescribed by Rule 25-22.060, Florida Administrative Code. Judicial review of a preliminary, procedural or intermediate ruling or order is available if review of the final action will not provide an adequate remedy. review may be requested from the appropriate court, as described above, pursuant to Rule 9.100, Florida Rules of Appellate Procedure.
