Dear Mr. Keen:

Your letter of March 22, 1999, has been received. In the letter you advised that you had purchased Sunrise Water Company, Inc. (Sunrise). This is the third utility you have purchased in recent years. The first, Lake Region Paradise Island system was not certificated when you purchased it and we are still working with you to correct deficiencies on the application so it may be approved. The second, Alturas Water Works system was certificated when you entered into a contract to purchase the utility and commission approval was received prior to your closing on the purchase. The third, Sunrise, was certificated, however, you closed on the purchase prior to receiving commission approval. I must remind you of Section 367.071, Florida Statutes, which states:

- (1) No utility shall sell, assign, or transfer its certificate of authorization, facilities or any portion thereof, or majority organizational control without determination and approval of the commission that the proposed sale, assignment, or transfer is in the public interest and that the buyer, assignee, or transferee will fulfill the commitments, obligations, and representations of the utility.
- (2) The commission may impose a penalty pursuant to s. 367.161 when a transfer occurs prior to approval by the commission.

Your purchase of Sunrise prior to receiving commission approval is a serious violation of the Florida Statutes. This issue will be addressed in the agenda recommendation concerning the transfer of the Sunrise certificate to your corporation.

Enclosed with this letter is an application package for transfer of a certificate of authorization for a regulated water utility. Included in this package are:

- 1. Application for transfer of certificate pursuant to Section 367.071, Florida Statutes.
- 2. Chapter 367, Florida Statutes, contains the Commission's jurisdiction over private water and wastewater utilities in Florida. A copy of Section 367.071, which addresses applications for transfer of certificates is enclosed for your information.
- 3. Chapter 25-30, Florida Administrative Code, details the rules promulgated to carry out the jurisdiction of the Commission over private water and wastewater utilities. Copies of Rules 25-30.020, .025, .030, .032 and .037 regarding an application for transfer of certificate are enclosed for your information.
- 4. Sample publication/legal notice format and a list of utilities and governmental/regulatory agencies that must be notified in accordance with Commission Rule 25-30.030, Florida Administrative Code. Please note the expiration date on the list. If you have not performed the noticing by this date, you must request an updated list by contacting the undersigned.
- Model water tariff which contains all of the utility's rules, regulations, rates and charges. Pursuant to Rule 25-30.037, Florida Administrative Code, the transferee is required to file the appropriate tariff revisions reflecting the change in ownership. A computer disk containing the tariffs in WordPerfect format may be obtained by contacting the staff.

The original and five copies of the application and supporting documentation and the original and two copies of the tariff must be filed by June 11, 1999, with:
