I am in receipt of a Notice dated June 25, 1999 regarding the Florida Public Service Commission's Conference Agenda for July 6, 1999. According to the Agenda, it is your recommendation that the PSC not grant a certificate to One Tellino, to provide interexchange telecommunications service within the State of Florida and that the docket on this case be closed.

As you and I discussed on the telephone today, the basis of your recommendation was the failure of One Tel Inc. to provide a tariff that complies with the requirements of the Florida PSC. As you and I further discussed. One Tel Inc. is in the process of revising all of its tariffs, not only the proposed tariff for Florida. As a result, I explained that I have not yet obtained information regarding certain rates and services that must be included in the tariff in addition to the language you have specified. I confirmed to you that I expect the Information to be provided to me in the very near future and that I will provide you with a substitute tariff as soon thereafter as possible.

You stated that upon receipt of this letter of explanation, you would be able to send a memo to the Commission withdrawing your recommendation that the certificate be denied and the docket closed.

Thank you for your courtesy and assistance in this matter. If for any reason this letter does not adequately explain our position in this matter, please notify me, so that I can take any additional steps necessary to prevent the denial of the application for the certificate of authority for my client.
