Dear Ms. Bayo:

We the undersigned are members of the Board of Directors of Citrus Springs (Citrus County, Florida) Civic Association speaking for the more than 800 members of the association. In addition we represent this community of some 2650 residences consisting of more than 6000 citizens.

Citrus Springs is one of the communities which has been hit hard by various rulings of the FPSC in the past. The high cost of water and waste disposal leaves many of our residents in a position of having to choose between water for a daily bath or shower, flushing the toilet and other activities that you probably take for granted.

We urge the Florida Public Service Commission to approve the New Offer of Settlement and Proposal for Disposition of Mandate on Remand.

1. As we understand it there would be no surcharges. The amount due would be treated as an investment in the next rate case, payable over a 30 year period.

2. The prospective rate increase would be approximately 1.7 percent under the settlement proposal

3. The Company agrees not to file a rate case for a three-year period, meaning mid-2002, with the exclusion of automatic cost of living index filings..
