# Re: Your letter dated August 30, 1999, concerning Order No. PSC-99-1068-PAA-SU issued in Docket No. 971179-SU

Dear Mr. Giambattista:

I am responding to the above-noted letter which you sent to Ms. O'Sullivan. Ms. O'Sullivan is now employed by another state agency, and I have now been assigned to this docket.

As you noted, Order No. PSC-99-1068-PAA-SU, requiring refunds, was issued on May 25, 1999. However, because there had not yet been a formal hearing in this case, that Order was issued as Proposed Agency Action. Pursuant to the provisions of that Order, the Order would have become final and effective if no protest were received by the close of business on June 15, 1999.

However, because the Office of Public Counsel (OPC) filed a protest on that day, the Order did not become effective (except for the show cause proceeding). To consider OPC's protest, a hearing has been scheduled for April 13-14, 2000. Unfortunately, an earlier hearing date could not be secured.

Pursuant to the Order Establishing Procedure, issued July 26, 1999, the utility should pre-file its testimony on November 23, 1999, and OPC and any other intervenors should pre-file their testimony on December 30, 1999. Pending the outcome of that formal hearing, the utility continues to collect the CIAC gross-up subject to refund. Therefore, I have placed your letter on the correspondence side of the docket file.
