Dear Mr. Kaye:

The Commission's Division of Records and Reporting sent me a copy of its request for updated information which you returned, dated 3/9/99. You had marked through the address and liaison and telephone number and put new owner information. I am attaching a copy of three rules.

Rule 25-24.472, Florida Administrative Code, Improper Use of a Certificate, states that "No certificate of public convenience and necessity authorizing interexchange service may be sold, assigned or transferred by the holder to another, nor used as collateral for any purpose, without prior Commission approval."

The second is Rule 25-24.473, F.A.C., Application for Approval of Assignment or Transfer of Certificate, which provides that you and the new owner must submit a joint application for transfer of your certificate. An application is enclosed.

The third is Rule 25-24.474, F.A.C., Cancellation of a Certificate, which explains what steps must be taken to cancel an IXC certificate. Since you did not write a letter providing the information required by rule, I cannot open a docket to voluntarily cancel your certificate at this time.

In addition, I checked the Department of State, Division of Corporations' records and found that the corporation is still in your name, a copy of which is attached. This would have to be taken care of before we could process a transfer of your certificate to Mr. Walley.

Also, a company is responsible for the regulatory assessment fees until the certificate is canceled by the Commission, either voluntarily or involuntarily. The Commission's records show that the 1998 fees, including statutory penalty and interest charges, remain unpaid. Payment of the fees would have to be received before the Commission could

process your request for cancellation or transfer of certificate. Details of the minimum charges are provided below:

#### 25-24.472 improper Use of a Certificate.

(1) No certificate of public convenience and necessity authorizing interexchange service may be sold, assigned or transferred by the holder to another, nor used as collateral for any purpose, without prior Commission approval.

Specific Authority 350.127(2) FS. Law Implemented 364.32, 364.33, 364.335, 364.337, 364.345 FS. History-New 2-23-87.

#### 25-24.473 Application for Approval of Assignment or Transfer of Certificate.

- (1) A person desiring to obtain a certificate by assignment or transfer from the holder thereof shall submit jointly with the certificate holder an application on Commission Form PSC/CMU 31 (3/96), which is incorporated into this rule by reference. Form PSC/CMU 31 (3/96), entitled "Application Form for Authority to Provide Interexchange Telecommunications Service Between Points Within the State of Florida" may be obtained by contacting the Commission's Division of Telecommunications.
- (2) An original and 12 copies of the application shall be filed with the Division of Records and Reporting.
- (3) An application for assignment or transfer of a certificate will be granted if the Commission determines that such approval is in the public interest.
  - (4) A certificate may be assigned or transferred only as a whole.

#### 25-24.474 Cancellation of a Certificate.

- (1) The Commission may on its own motion cancel a company's certificate for any of the following reasons:
  - (a) Violation of the terms and conditions under which the authority was originally granted;
  - (b) Violation of Commission rule or order; or
  - (c) Violation of Florida Statutes.
- (2) If a certificated company desires to cancel its certificate, it shall request cancellation from the Commission in writing and shall provide the following with its request.
  - (a) Statement of intent and date to pay Regulatory Assessment Fee.
  - (b) Statement of why the certificate is proposed to be cancelled.
  - (c) A statement on treatment of customer deposits and final bills.
  - (d) Proof of individual customer notice regarding discontinuance of service.
- (3) Cancellation of a certificate shall be ordered subject to the holder providing the information required by subsection (2).
