NOTICE IS HEREBY GIVEN that the Staff of the Florida Public Service Commission will hold a customer meeting regarding the application of Florida Public Utilities Company, Fernandina Beach Division (Applicant), for increased rates and charges for water service, at the following time, date, and location:

The purpose of the meeting is for the Applicant's customers to provide sworn testimony concerning the quality of service provided by Applicant and such other matters as may pertain to Applicant's application for increased rates and charges.

At the beginning of the meeting, procedures will be set up to establish an order for comments. The Commission staff will be available to coordinate customer comments and to assist members of the public.

All persons who wish to comment are urged to be present at the beginning of the meeting, since the meeting may be adjourned early if no customers are present. The meeting will begin as scheduled and will continue until all the customers have been heard.

In addition to the customer meeting to be held on November 3, 1999, the Commission staff will be available the morning of November 4, 1999, to meet with individual customers who desire a more in-depth discussion of the issues. Appointments may be set up by contacting Mrs. Connie Binford of the Commission staff at (850) 413-7011 prior to November 3, 1999, or signing up at the customer meeting on November 3, 1999. All persons who wish to participate in the November 4, 1999 meeting are urged to make an appointment, since the meeting may be canceled if no customers sign up.

Finally, the Commission staff is also attempting to meet with representatives of customer groups and homeowners associations on the afternoon on November 3, 1999. If you are a representative of a customer group or homeowners association and you have not been contacted by the Commission staff, please contact Mrs. Connie Binford of the Commission staff at (850) 413-7011 prior to November 3, 1999.
