CASE BACKGROUND

- 06/14/96 This company obtained Florida Public Service Commission PATS Certificate No. 4631.
- **12/10/98** The Division of Administration mailed the regulatory assessment fee (RAF) notice. In accordance with Florida Statute 350.113(4), the Commission "shall provide each regulated company with written notice of the date that payment of the fee is due at least 45 days prior to such date", which would put the due date to February 1, 1999.
- 03/17/99 The Division of Administration mailed a delinquent letter.

- 09/27/99 Mr. Armando Abad, President, called and requested information about this docket. Staff was advised that the company would pay the outstanding balance and make a settlement offer.
- **10/05/99** The Commission voted at today's Agenda Conference to impose a \$500 fine or cancel the company's certificate. Later, the Commission received the company's check for the outstanding amount, including statutory penalty and interest charges, and a proposal to pay a \$100 settlement and a promise to pay future regulatory assessment fees on a timely basis. The company reported revenues of \$1,596.00 for the period ending December 31, 1998.
- **10/22/99** Order No. PSC-99-2091-PAA-TC was issued, which imposed a \$500 fine or canceled the company's certificate.

Staff believes the following recommendations are appropriate.

DISCUSSION OF ISSUES

ISSUE 1: Should the Commission accept the settlement offer proposed by A.M.A., Inc. to resolve the apparent violation of Rule 25-4.0161, Florida Administrative Code, Regulatory Assessment Fees; Telecommunications Companies?

RECOMMENDATION: Yes. The Commission should accept the company's settlement proposal. Any contribution should be received by the Commission within ten business days from the date of the Commission Order and should identify the docket number and company name. The Commission should forward the contribution to the Office of the Comptroller for deposit in the State General Revenue Fund pursuant to Section 364.285(1), Florida Statutes. If the company fails to pay in accordance with the terms of the Commission Order, the company's certificate should be canceled administratively. (Isler)

STAFF ANALYSIS: After the October 5, 1999 Agenda Conference, the Commission received the company's payment for the outstanding regulatory assessment fee, including statutory penalty and interest charges, and a letter from the company's president, Mr. Armando Abad, which offered a settlement in the amount of \$100 and proposal to pay future RAFs on a timely basis.

Accordingly, staff believes the terms of the settlement agreement as summarized in this recommendation should be accepted. Any contribution should be received by the Commission within ten business days from the date of the Commission Order and should identify the docket number and company name. The Commission should forward the contribution to the Office of the Comptroller for deposit in the State General Revenue Fund pursuant to Section 364.285(1), Florida Statutes.
