ORDER APPROVING ADOPTION OF INTERCONNECTION AND RESALE AGREEMENT AND APPROVED AMENDMENTS

BY THE COMMISSION:

By letter dated October 14, 1999, Sprint-Florida, Incorporated (Sprint-Florida) and Supra Telecommunications and Information Systems, Incorporated (Supra) filed a notice of adoption in its entirety of the interconnection and resale agreement and any amendments to this agreement entered into and between Sprint-Florida and MCImetro Access Transmission Services, Inc., pursuant to 47 U.S.C. §252(i) of the Telecommunications Act of 1996 (the Act). This agreement was approved by the Commission by Order No. PSC-97-0565-FOF-TP, issued on May 20, 1997, and is incorporated by reference herein. A copy of the agreement and the approved amendments may be obtained from the official docket file by contacting our Division of Records and Reporting.

Both the Act and Chapter 364, Florida Statutes, encourage parties to enter into negotiated agreements to bring about local exchange competition as quickly as possible. Under the requirements of 47 U.S.C. § 252(e), negotiated agreements must be submitted to the state commission for approval. Section 252(i) requires that a local exchange carrier shall make available any interconnection, service, or network element provided under an agreement approved by the state commission to any other requesting telecommunications carrier upon the same terms and conditions as those provided in the agreement in its entirety. Further, Section 252(e)(4) requires the state to reject or approve the agreement within 90 days after submission or it shall be deemed approved.

The adoption of this agreement shall be effective on the date of issuance of this Order and will expire on the date specified in

the agreement or the approved amendments. This agreement governs the relationship between the companies regarding local interconnection and the exchange of traffic pursuant to 47 U.S.C. §251. Upon review of the proposed adoption, we find that it complies with the Act; thus, we hereby approve it. We note that we hereby approve the adoption of the amendments to the agreement that we have approved as of the issuance of this Order. Sprint-Florida and Supra shall file with the Commission a copy of all amendments to this agreement approved after the issuance of this Order and shall also cross reference this docket in their future filings.

Based on the foregoing, it is

ORDERED by the Florida Public Service Commission that Sprint-Florida, Incorporated and Supra Telecommunications and Information Systems, Incorporated's adoption in its entirety of Sprint-Florida, Incorporated and MCImetro Access Transmission Services, Inc.'s interconnection and resale agreement and all amendments to this agreement, approved by this Commission as of the issuance of this Order, and incorporated by reference in this Order, is hereby approved. A copy of the agreement and the approved amendments may be obtained as specified in the body of this Order. It is further

ORDERED that any amendments to this agreement, approved by the Commission after the issuance of this Order, must be filed with the Commission cross referencing this docket. It is further

ORDERED that this docket is hereby closed.
