### **PURPOSE**

The purpose of these workshops is to discuss interim performance metrics and their incorporation into the draft Third-Party OSS Master Test Plan (MTP).

## COMMENTS AND PRESENTATIONS

Parties and interested persons are asked to provide written comments and suggestions regarding performance metrics using the September 15, 1999, BellSouth Service Quality Measures as the baseline metrics. Comments and suggestions should be prioritized extent possible, and include suggestions regarding the performance measures, retail analogs/benchmarks, and statistical methodology. In addition, for each proposed modification to the baseline metrics, please use the following format: measurement name; 2) the definition of the measurement; exclusions; 4) business rules; 5) calculations; 6) structure; 7) level of disaggregation; 8) data retained relating to experiences; 9) data retained relating to BellSouth performance; and 10) the retail analog/benchmark. Furthermore, and suggestions should include the rationale for modifications to the baseline metrics. Comments should be filed with the Division of Records and Reporting, Gerald L. Gunter 2540 Shumard Oak Boulevard, Tallahassee, Florida Building, 32399-0850, on or before November 19, 1999, specifically referencing Docket No. 960786-TL.

At the December 1, 1999, workshop, participants will be allowed to make oral presentations regarding proposed revisions to the baseline metrics, following brief comments by KPMG and Commission staff. The presentations may not exceed 40 minutes. Those wishing to make presentations should forward a brief summary of the presentation to Beth Keating, Division of Legal Services, 2540 Shumard Oak Boulevard, Tallahassee, FL 32399-0850, by 5:00 p.m. on November 23, 1999. In view of the time limitations of this workshop, parties are strongly encouraged to consider working together to consolidate presentations to the extent possible. It should be noted that the
