GLOBAL NAPs, INC.'S MOTION FOR EXTENSION OF TIME TO FILE TESTIMONY

Pursuant to Florida Administrative Code Rule 28-106.204, Florida Administrative Code, Global NAPs, Inc., moves the Commission to extend the timeframe and deadline for filing direct testimony in Docket No. 991267 from November 16, 1999, to November 24, 1999. As grounds for this Motion, Global NAPs states the following:




