This is in response to your letter dated September 30, 1999 requesting cancellation of your IXC certificate effective March 31, 1999. Rule 25-24.474(2)(a), (b), (c), and (d), F.A.C., Cancellation of a certificate states:

(2) If a certificated company desires to cancel its certificate, it shall request cancellation from the Commission in writing and shall provide the following with its request:

- (a) Statement of intent and date to pay Regulatory Assessment Fee.
- (b) Statement of why the certificate is proposed to be cancelled.
- (c) A statement on treatment of customer deposits and final bills.
- (d) Proof of individual customer notice regarding discontinuance of service.

Your letter did not provide any of the above information. In addition, Commission records show that the 1997 regulatory assessment fee was paid after the January 30, 1998 due date, which means statutory penalty and interest charges are applicable. You paid the minimum \$50.00 fee on February 11, 1998, but did not pay the \$2.50 penalty and \$.50 interest.

Once I receive your check for the \$3.00 and a letter providing the information required by rule, I will be happy to open a docket to grant Hellenicom Long Distance a voluntary cancellation of its certificate. However, the effective date of the cancellation will be October 5, 1999, the date your original request was received, not March 31, 1999. Please respond in writing by October 25.
