By memorandum dated November 1, 1999, copy attached, staff advised Records and Reporting that Orders Nos. PSC-99-1909-PAA-WS and PSC-99-2081-CO-WS had been issued in Docket No. 981858-WS thereby disposing of the territory issue remaining in Docket No. 981930-WU. As a consequence, staff requested that Docket No. 981930-WU be administratively closed pursuant to authorization in Order No. PSC-99-1220-FOF-WU. However, staff did not include instructions to cancel Certificate No. 571-W, as well.

Therefore, this supplemental memo serves as staff's request that Certificate No. 571-W, issued to Fiveland Investments, Inc., be canceled pursuant to staff's November 1, 1999 memorandum. The effective date of the cancellation should be the date the utility became non-jurisdictional which was December 30, 1998.

RE: Docket No. 981930 WILL Amily Am Docket No. 981930-WU, Application for transfer of facilities of Fiveland Investments,

Inc. to Charlotte County, and cancellation of Certificate No. 571-W.

Order No. PSC-99-1220-FOF-WU, issued June 21, 1999, ordered that Docket No. 981930-WU remain open pending resolution in Docket No. 981858-WS of the problem regarding the overlapping territory, as discussed in the body of the order. At that time, Docket No. 981930-WU was to be administratively closed.

Attached are copies of Orders Nos. PSC-99-1909-PAA-WS, issued September 27, 1999, and PSC-99-2081-CO-WS, issued October 21, 1999, in Docket No. 981858-WS. The former order disposes of the problem of the overlapping territory by excluding the portion of the territory which overlaps that of Fiveland Investments, Inc. The latter order makes the action effective and final.

Consequently, there are no pending issues in Docket No. 981930-WU and the docket should be administratively closed.
