NOTICE OF PROPOSED AGENCY ACTION ORDER APPROVING ASSIGNMENT OF AND NAME CHANGE ON INTEREXCHANGE TELECOMMUNICATIONS CERTIFICATE

BY THE COMMISSION:

NOTICE is hereby given by the Florida Public Service Commission that the action discussed herein is preliminary in nature and will become final unless a person whose interests are substantially affected files a petition for a formal proceeding, pursuant to Rule 25-22.029, Florida Administrative Code.

On January 10, 2000, Telecommunications Service Center, Inc. (Telecommunications Service Center) and CyberSentry, Inc. (CyberSentry) filed with this Commission a joint request for assignment of and name change on Interexchange Telecommunications (IXC) Certificate No. 3484 from Telecommunications Service Center to CyberSentry.

Telecommunications Service Center and CyberSentry have complied with Rule 25-24.473, Florida Administrative Code, regarding the assignment of IXC certificates. We find the assignment to be in the public interest and, therefore, approve the

assignment. IXC Certificate No. 3484 shall be amended to reflect that CyberSentry is the holder of this certificate.

If this Order becomes final and effective, it shall serve as CyberSentry's certificate. It should, therefore, be retained by CyberSentry as proof of certification and as evidence of the name change.

IXCs are subject to Chapter 25-24, Florida Administrative Code, Part X, Rules Governing Telephone Service Provided by Interexchange Telephone Companies. IXCs are also required to comply with all applicable provisions of Chapter 364, Florida Statutes, and Chapters 25-4, Florida Administrative Code. Further, pursuant to the provisions of Order No. 16804, issued November 4, 1986, IXCs may not construct facilities to bypass a local exchange company without the prior approval of this Commission.

Based on the foregoing, it is

ORDERED by the Florida Public Service Commission that the request for assignment of and name change on Interexchange Telecommunications Certificate No. 3484 from Telecommunications Service Center, Inc. to CyberSentry, Inc., is hereby approved. It is further

ORDERED that Interexchange Telecommunications Certificate No. 3484 shall be amended to reflect that CyberSentry, Inc., is the holder of this certificate.

ORDERED that CyberSentry, Inc. Interexchange Telecommunications service Certificate No. 3484 is subject to the terms and conditions set forth in the body of this Order. It is further

ORDERED that this Order will serve as CyberSentry, Inc.'s certificate and that this Order should be retained as proof of certification and as evidence of the name change. It is further

ORDERED that the provisions of this Order, issued as proposed agency action, shall become final and effective upon the issuance of a Consummating Order unless an appropriate petition, in the form provided by Rule 28-106.201, Florida Administrative Code, is received by the Director, Division of Records and Reporting, 2540 Shumard Oak Boulevard, Tallahassee, Florida 32399-0850, by the
