Dear Mr. Jackson:

This letter is a follow-up of the telephone discussion between Ms. Stephanie Clapp of my staff and you earlier this week. According to Ms. Clapp, the discussion centered around whether the Woodlands of Lake Placid, L.P. (Woodlands) has any directly billed wastewater customers. Since the Lake Placid Homeowners Association is billed on a quarterly basis for wastewater usage of all of its members, it does appear that the Woodlands' wastewater service meets the definition of a utility, pursuant to Section 367.021(12), Florida Statutes, and must apply for certification.

Enclosed with this letter is an information package to comply with Rule 25-30.034, Florida Administrative Code, for an original certificate to operate a wastewater utility which is already in existence and charging for service. Included in this package are:

- 1. Application for certificate pursuant to Section 367.045, Florida Statutes.
- 2. Chapter 367, Florida Statutes, contains the Commission's jurisdiction over private water and wastewater utilities in Florida. A copy of Section 367.045, regarding applications for an original certificate is enclosed for your information.
- 3. Chapter 25-30, Florida Administrative Code, details the rules promulgated to carry out the jurisdiction of the Commission over private water and wastewater utilities. Copies of Rules 25-30.020, .025, .030, .031, .032 and .034 regarding an application for an original certificate are enclosed for your information.

- 4. Sample publication/legal notice format and a list of utilities and governmental/regulatory agencies that must be notified in accordance with Commission Rule 25-30.030, Florida Administrative Code. Please note the expiration date on the list. If you have not performed the noticing by this date, you must request an updated list by contacting the undersigned.
- 5. Instructions for preparation of territory description and map.
- 6. Sample wastewater tariff format which will contain all of the utility's rules, regulations, rates and charges. A computer disk containing the tariff in WordPerfect 6.1 format may be obtained by contacting the staff.

The original and five copies of the application and supporting documentation, one copy of the maps and the original and two copies of the tariff, with a notation that the application should be added to the above referenced docket, must be filed with:
