Dear Mr. Hyland:

This is a follow up to my telephone conversation yesterday with Mrs. Hyland. She had told me that she believed you had written on the 1998 regulatory assessment fee form that you did not have any payphones and requested cancellation of your certificate. I asked the Commission's Division of Administration to pull your 1998 form, a copy of which is attached. As you can see, there is no such notation and the form shows one payphone still in service at the end of December 1998.

Since the Commission has no record of receiving a request for cancellation of your certificate, you will need to pay the 1999 fee, along with accrued penalty and interest charges, and return it with a letter requesting cancellation of your certificate with an effective date of December 31, 1999. After your check and letter are received, I will open a docket to cancel your certificate. If your check is postmarked in February, the minimum amount due is \$53.00 (\$50.00 fee, \$2.50 penalty, and \$.50 interest). If your check is postmarked in March, the minimum amount due is \$56.00 (\$50.00 fee, \$5.00 penalty, and \$1.00 interest).
