

AMENDED NOTICE OF APPEAL

NOTICE IS GIVEN that Joseph Devine, Ronald Ludington and Donald Gill, Appellants, appeals to the Florida First Circuit Court of Appeals, the order, PSC-99-2444-AS-SU of the Public Service Commission rendered December 14, 1999. The nature of the order is a final order, (1) is that each of the findings made in the body of the Order was hereby approved in every respect. (2) that the October 12, 1999, Emergency Motion to remove Jack Shreve and Steve Reilly as Counsel of Record filed by Mr. Gill and Mr. Devine was denied. (3) the settlement agreement filed on October 7, 1999, by Mr. Ludington was rejected, (4) the September 2, 1999 settlement agreement between the Office of Public Counsel and North Fort Myers Utility, Inc., was approved, (5) the transfer of Buccaneer Utility's wastewater facilities to North Fort Myers Utilities, Inc., was approved, (6) that North Fort Myers Utility [sic] shall charge the customers in the territory added herein the rates and charges approved in its tariffs until authorized to change by this Commission. (7) that Certificate No. 247-S, held by North Fort Myers Utility, Inc., is hereby amended to include the territory described in Attachment A of this Order. (8) that this docket is hereby closed. This nature of the order is a Final Order.


