Dear Mr. De Oliveira:

I faxed you a note on March 13 and explained that the 1999 regulatory assessment fee must be paid in full before I could go forward with this docket. On March 27, your check for \$50.00 for the 1999 fee was mailed and has been received. However, you did not pay the statutory penalty and interest charges of \$6.00. In Order No. PSC-99-2480-PAA-TI, which was issued on December 20, 1999, the Commission stated that either a \$500 fine would be assessed or that the certificate would be cancelled. Although you protested the Order by making a \$100 settlement offer, I cannot recommend that the settlement be accepted when there is still an outstanding balance.

Unless you respond in writing by April 20, 2000 by paying the past due amount in full, we will consider that you have withdrawn your protest. The Commission's Order No. PSC-99-2480-PAA-TI will then become final and your certificate will be cancelled.
