RESOLUTION NO. 18-00

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ORANGE CITY, FLORIDA, SUPPORTING VOLUSIA COUNCIL OF GOVERNMENTS PROPOSAL TO THE FLORIDA PUBLIC SERVICE COMMISSION FOR A NEW, SINGLE AREA CODE OF "386" (FUN) FOR ALL TELECOMMUNICATIONS SUBSCRIBERS IN VOLUSIA COUNTY TO REPLACE 904 AND 407 IN VOLUSIA COUNTY, FLORIDA.

WHEREAS, the Volusia Council of Governments (VCOG) was established in January, 1970, as a council of local public officials to develop coordinated plans, programs, and policies of mutual interest; and

WHEREAS, the Governing Board of VCOG is comprised of representatives from the Cities of Daytona Beach, Daytona Beach Shores, Debarry, Deland, Deltona, Edgewater, Holly Hill, Lake Helen, New Smyrna Beach, Oak Hill, Orange City, Ormond Beach, Pierson, Ponce Inlet, Port Orange, South Daytona and the County of Volusia; and

WHEREAS, the City recognizes the explosive growth in telecommunications is rapidly exhausting telephone area code numbers; and

WHEREAS, the City recognizes that the 904 area code applies to the greatest majority of telephone subscribers in Volusia County and is soon to run out of numbers and is likely to be replaced with a new area code; and

WHEREAS, Volusia County has sparkling beaches and endless other leisure activities as well as being the home of the world-famous beach that is a FUN place to live and visit.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Orange City, Florida:

SECTION 1. That the City Council of the City of Orange City supports VCOG's recommendation for a single, new area code for all telecommunications subscribers in Volusia County.

SECTION 2. That the City Council of the City of Orange City endorses "386" (FUN) as the single, new area code for all of Volusia County.

SECTION 3. That the City Clerk is hereby directed to forward a certified copy of this Resolution to the Public Service Commission.

SECTION 4. All resolutions or parts of resolutions in conflict herewith be and the same are hereby repealed.
