NOTICE OF PROPOSED AGENCY ACTION ORDER CANCELLING ALTERNATIVE LOCAL EXCHANGE TELECOMMUNICATIONS CERTIFICATE

BY THE COMMISSION:

NOTICE is hereby given by the Florida Public Service Commission that the action discussed herein is preliminary in nature and will become final unless a person whose interests are substantially affected files a petition for a formal proceeding, pursuant to Rule 25-22.029, Florida Administrative Code.

MiComm Services, Inc. (MiComm Services), holder of Alternative Local Exchange Telecommunications Certificate (ALEC) of Public Convenience and Necessity No. 5253, has requested the cancellation of ALEC Certificate No. 5253. MiComm Services has complied with the provision of Rule 25-24.820(2), Florida Administrative Code, by providing adequate notice in writing of its request for cancellation of its ALEC certificate and by submitting its regulatory assessment fees (RAFs) for 1999. Accordingly, we find it appropriate to cancel ALEC Certificate No. 5253, effective March 30, 2000.

MiComm Services shall return its certificate to this Commission. In addition, under Section 364.336, Florida Statutes, certificate holders must pay a minimum annual Regulatory Assessment Fee of \$50 if the certificate was active during any portion of the

calendar year. A RAFs Return notice for The year 2000 will be mailed to MiComm Services. Neither the cancellation of its certificate nor the failure to receive a RAFs Return notice for the year the year 2000 shall relieve MiComm Services from its obligation to pay RAFs for the year 2000.

Based on the foregoing, it is

ORDERED by the Florida Public Service Commission that MiComm Services, Inc.'s Certificate No. 5253 to provide Alternative Local Exchange Telecommunications services is hereby cancelled, effective March 30, 2000. It is further

ORDERED that MiComm Services, Inc. shall return its certificate to this Commission and remit Regulatory Assessment Fees for the year the year 2000. It is further
