Sprint PCS is a Commercial Mobile Radio Service (CMRS) provider licensed by the Federal Communications Commission to provide service in Florida.
- 3. The instant proceeding involves numbering relief for the 941 NPA where Sprint provides service and may involve proposals to require certain number resource management practices to be followed by service providers, including Sprint. Each of the Sprint providers named above utilizes or may utilize NXX codes in the 941 Area code in the day-to-day course of providing service to its customers. Any determination by the Commission in this docket will affect the substantial interests of Sprint.
