

BELLSOUTH TELECOMMUNICATIONS, INC.'s NOTICE OF INTENT TO REQUEST TEMPORARY WAIVER OF PHYSICAL COLLOCATION REQUIREMENTS IN THE PERDIDO BAY CENTRAL OFFICE

COMES NOW, BellSouth Telecommunications, Inc. ("BellSouth" or "Company"), and files its Notice of Intent to request a temporary waiver of the physical collocation requirements in the Perdido Bay central office pursuant to Order No. PSC-99-1744-PAA-TP issued September 7, 1999.

- 1. BellSouth is unable to completely fulfill a request for physical collocation in this office due to the lack of space. Currently, BellSouth has plans to complete a building addition in this office at the end of the fourth quarter of 2002. Once the addition is complete, there will be sufficient space to provide requesting ALECs physical collocation in this office.
- 2. BellSouth has attached the detailed diagram as required by PSC-99-1744-PAA-TP.
- 3. BellSouth will file its petition for waiver 20 days from the date of this filing.

- 4. The original of this notice has been filed with the Division of Records and Reporting.
- 5. As of this date, one application for space in this office has been denied partially as there is insufficient space to fill the request. Therefore, BellSouth is moving forward with the request for temporary waiver at this time.
