I believe Patti can answer that question -- the County rescinded Commission jurisdiction on February 27, 1996 -- the Commission acknowledged this rescission by Order No. PSC-96-0582-FOF-WS, issued May 3, 1996, but said certificates would be surrendered for cancellation within 30 days of the conclusion of Docket No. 930945-WS about whether the Commission had continuing jurisdiction. The Appeals Court issued its opinion on December 12, 1996, saying we did not have jurisdiction -- therefore, the certificates should have been canceled within 30 days of that date (however, Mandate was not issued until February 11, 1997 and the docket was not ultimately closed until 2/20/97). The memo closing docket said that with the decision of the First District there were no further actions to be taken. Therefore, I would show certificates canceled as of no later than January 11, 1997 (and possibly Dec. 12, 1996), but RAF responsibility ending as of Feb. 27, 1996 -- does anyone have a different interpretation -- and should the cancellation date be the opinion date, mandate date, memo closing docket date, 30 days after any of those dates or some other date?

I have conferred with staff and reviewed the applicable orders -- pursuant to Order No. PSC-96-0582-FOF-WS, issued May 3, 1996, Certificates Nos. 452-W and 386-S were to be canceled if a decision was rendered that the Commission did not have jurisdiction over Florida Water's Marco Island operation. By Opinion dated 12/12/96, the First District Determined that the Commission did not have jurisdiction. Pursuant to Order No. PSC-96-0582-FOF-WS, issued May 3, 1996, the above-referenced docket may be closed once all pending dockets before the Commission have been closed. Docket No. 950495-WS was the last pending docket before the Commission relating to systems in Collier County. Docket No. 950495-WS was pending appeal to the First DCA on various issues. However, in that docket, the final order on remand approving a modified offer of settlement, Order No. PSC-991794-FOF-WS, was issued on September 14, 1999, closing Docket No. 950495-WS. Therefore all pending dockets before the Commission relating to systems in Collier County have been closed and staff is requesting that this docket be closed administratively.
