Section 364.33, Florida Statutes, provides that a person may not acquire ownership or control of any telecommunications facility, or any extension thereof for the purpose of providing telecommunications services to the public, including the acquisition, transfer, or assignment of majority organizational control or controlling stock ownership, without prior approval from this Commission.

By letter dated April 27, 2000 STAR Telecommunications, Inc. (STAR), AS Telecommunications, Inc.(AS), PT-1 Communications, (PCI), PT-1 Long Distance, Inc. (PLDI), CEO Communications, Inc. STI Merger Co. (STI) filed with this Commission an (CEO) and application for approval of agreement and plan whereby STAR (holder of IXC Certificate No. 5255), AS (holder of IXC Certificate No. 3510), PCI (holder of IXC Certificate 4432), PLDI (holder of IXC Certificate No. 7110), CEO (holder of IXC Certificate No. 4073), will merge with and into STI Merger Co., a wholly owned subsidiary The companies have stated that the of World Access, Inc.. transaction will be virtually transparent to their customers in Florida and it will not affect the services being provided. The companies have stated that they will continue to operate under their existing certificated names and tariffs on file with this Commission.

In accordance with our authority under Section 364.33, Florida Statutes, to approve the acquisition or transfer of majority organizational control or controlling stock ownership of a telecommunications company providing service in Florida, we have reviewed the Petition of STAR, AS, PCI, PLDI, CEO and STI, and find it appropriate to approve it. We have based our review and decision upon an analysis of the public's interest in efficient, telecommunications service. Our decision does not reliable address the potential impact of the transfer on the competitive market in Florida, or on the companies' or their competitors' We emphasize, however, that our approval of the interests. Petition pursuant to our authority under Section 364.33, Florida Statutes, does not preclude us from addressing any of our concerns that may arise regarding this transaction to the appropriate federal or state agencies.

Based on the foregoing, it is,
