Petitioner, Legal Environmental Assistance Foundation, Inc., ("LEAF"), files this Petition to Intervene pursuant to Rules25-22.039, FAC, and as grounds therefore states:

1. LEAF is located at 1114 Thomasville Road, Suite E, Tallahassee, FL.

3. LEAF's substantial interests are subject to determination and will be affected through this proceeding. LEAF has a substantial interest in the Commission's decision to affect interconnection of small photovoltaic systems and in securing the environmental and health benefits of increased efficiency and sustainability of energy services and increased use of cleaner energy resources to meet energy needs.

4. LEAF is a public interest advocacy organization whose corporate purposes include protection of public health and the environment. The Commission's action in this docket will substantially influence how energy services are provided and which energy resources (including solar and efficiency resources) are relied upon, thereby influencing the environmental and health impacts of meeting Florida's energy service needs. A substantial number of LEAF's members have an interest in the environmental and energy effects that will occur as a result of a decision in This docket, including the potential for increased use of sustainable energy supplies.

5. Tampa Electric Company's Petition in this case was filed, in part, under the terms of an agreement between TECO and LEAF in settlement of a prior legal proceeding.

6. At issue are the terms and conditions under which TECO's customers will be allowed or required to interconnect small photovoltaic systems to the electric grid and the ease with which such interconnection will be made. LEAF reserves the right to raise additional issues as they become known.

7. The following statutes and rules entitle LEAF to relief: Rules 25-17, 25-22, 25 and 25-106, FAC; and Chapters 120 and 366, Florida Statutes. LEAF reserves the right to rely on additional legal authority.

WHEREFORE, LEAF respectfully requests that the Commission grant its request to

intervene as a party to this proceeding.
