Teleglobe USA Inc. hereby submits for filing its Regulatory Assessment Fee Return. A check in the amount of \$53.03 payable to the Florida Public Service Commission is also enclosed.

Teleglobe has earlier advised the Commission staff that the filing of this Report would be delayed, and deeply regrets any inconvenience this may have caused. We have taken steps to ensure that future filings will be done in a timely manner. The process internally was more complex than we had anticipated.

Please note, that while intrastate revenue information on the form and thereby the actual Return is accurate (there were none), the gross operating revenues for Teleglobe USA are estimated (the final revenue numbers are not yet available).

Teleglobe respectfully requests proprietary treatment of the financial information submitted herein. Teleglobe USA Inc., is an ultimate subsidiary of Teleglobe Inc., a corporation publicly traded on New York, Toronto and Montreal Stock Exchange. Pursuant to the Securities and Exchange Act of 1934, as well as corresponding Canadian law, Teleglobe Inc. publishes its financial information in the aggregate. The financial information for individual subsidiaries is not a matter of public record. A release of revenue information for Teleglobe USA Inc. would disclose sensitive information, which would be useful to Teleglobe's competitors in the international marketplace but provide no useful public interest purpose to Florida consumers. Note again that Teleglobe has no Florida intrastate revenues.

This claim of confidentiality was filed by or on behalf of a "telco" for Confidential DN 09344-00. The document is in locked storage pending advice on handling. To access the material, your name must be on the CASR. If undocketed, your division director must obtain written EXD/Tech permission before you can access it.
