BY THE COMMISSION:

Michael T. Baldwin (Baldwin), holder of Pay Telephone Certificate (PATS) of Public Convenience and Necessity No. 7417, has requested the cancellation of PATS Certificate No. 7417. Baldwin has complied with the provision of Rule 25-24.514(2), Florida Administrative Code, by providing adequate notice in writing of his request for cancellation of his PATS certificate and by submitting his regulatory assessment fees (RAFs) for 1999. Accordingly, we find it appropriate to cancel PATS Certificate No. 7417, effective August 7, 2000.

Baldwin shall return his certificate to this Commission. In addition, under Section 364.336, Florida Statutes, certificate holders must pay a minimum annual Regulatory Assessment Fee of \$50 if the certificate was active during any portion of the calendar year. A RAFs Return notice for 2000 has been mailed to Baldwin. Neither the cancellation of his certificate nor the failure to receive a RAFs Return notice for the year 2000 shall relieve Baldwin from his obligation to pay RAFs for 2000.

Based on the foregoing, it is

ORDERED by the Florida Public Service Commission that Michael T. Baldwin's Certificate No. 7417 to provide Pay Telephone services is hereby canceled, effective August 7, 2000. It is further

ORDERED that Michael T. Baldwin shall return his certificate to this Commission. It is further

ORDERED that this Docket is closed.

Any party adversely affected by the Commission's final action in this matter may request: 1) reconsideration of the decision by filing a motion for reconsideration with the Director, Division of Records and Reporting, 2540 Shumard Oak Boulevard, Tallahassee, Florida 32399-0850, within fifteen (15) days of the issuance of this order in the form prescribed by Rule 25-22.060, Florida Administrative Code; or 2) judicial review by the Florida Supreme Court in the case of an electric, gas or telephone utility or the First District Court of Appeal in the case of a water and/or wastewater utility by filing a notice of appeal with the Director, Division of Records and reporting and filing a copy of the notice of appeal and the filing fee with the appropriate court. filing must be completed within thirty (30) days after the issuance of this order, pursuant to Rule 9.110, Florida Rules of Appellate Procedure. The notice of appeal must be in the form specified in Rule 9.900(a), Florida Rules of Appellate Procedure.
