Dear Ms. Bayo:

In accordance with the provisions of the above referenced Order, Lindrick Service Corporation is required to report the total revenue collected from wastewater customers and the additional revenue collected through both the temporary and emergency rates by the 20th of the month following collections.

The attached chart records wastewater revenue (as a proportion of total revenue) received during the month of September (both current and past due amounts). Total revenue for September appears somewhat higher than previous months due in part to the late billing date for July (more past due collections than normal during September).

A copy of the bulk wastewater bill for August is attached for your records.

Once again, utility collections for the portion of the Temporary Rates intended to cover the cost of sewage treatment purchased from the City of New Port Richey are short (as they have been in previous months). In addition, the total amount collected for June, July and August service attributable to the temporary increase is significantly less than the monthly average increase of \$56,864 permitted by the Order (by \$39,791 over a 3 month period). Past due collections may reduce these shortfalls somewhat, however, current rates are obviously insufficient to meet utility expenses.


