BELLSOUTH TELECOMMUNICATIONS INC.'S NOTICE OF PARTIAL WITHDRAWAL OF MOTION FOR RECONSIDERATION

On March 15, 2000, the Florida Public Service Commission ("Commission") entered a Final Order (PSC-00-0537-FOF-TP) in the Arbitration proceeding between BellSouth Telecommunications, Inc. ("BellSouth") and ITC^DeltaCom Communications, Inc. ("DeltaCom") in Docket Number 990750-TP. On March 30, 2000, BellSouth filed a Motion for Reconsideration asking the Commission to reconsider, among other things, the finding that the parties should pay reciprocal compensation at a rate of \$.009 per minute of use.

Subsequent to BellSouth's Motion for Reconsideration, the Parties reached a resolution of the reciprocal compensation issue. Thus, BellSouth provides notice to the Commission that BellSouth withdraws the request for reconsideration as to the reciprocal compensation rate issue. The withdrawal is limited to the reciprocal compensation rate issue and has no effect on the remaining two issues that are also the subject of the Motion for Reconsideration.
