the hearing. However, we do have outstanding discovery 1 requests that we have served on BellSouth, and I guess I 2 just need to await the service of their documents and 3 responses. But at this point, we certainly have not 4 prefiled any confidential exhibits. 5 COMMISSIONER JABER: All right. And I would 6 7 just bring to your attention that you have to let us know seven days before the hearing. And if anything comes in 8 9 after the seven days, just give a courtesy phone call to 10 BellSouth and to Staff, follow the procedures that are set 11 forth in the prehearing order. 12 Okay. Any changes or questions on Page 4? 13 Please notice the page limit for briefs is 40 pages, and 14 also notice the addition with respect to oral summaries of 15 testimony being limited to five minutes. 16 Page 5. Is there any objection to taking direct 17 and rebuttal up at the same time? 18 MR. HOFFMAN: Commissioner Jaber, we were going 19 to raise that anyway, so we concur with that approach. 20 MR. | 9 | may either preempt or otherwise impact the Commission's |
| 10 | ability to resolve any of the issues presented or the |
| 11 | relief requested in this matter. |
| 12 | Just to give you a historical perspective, you |
| 13 | may recall there had been three or four matters where the |
| 14 | Commissioners found it helpful either right at the hearing |
| 15 | or during an agenda conference to take up some legal |
| 16 | matters. I would like to have those kinds of things |
| 17 | addressed early on. So if there is a court decision or a |
| 18 | FCC decision that impacts this case in any way, it's my |
| 19 | intent to allow the parties to address that in the brief. |
| 20 | To the degree there are decisions we need to take official |
| 21 | recognition of in lieu of your addressing it in the brief |
| 22 | or in addition to your addressing it in the brief, I would |
| 23 | expect to handle that at the beginning of the hearing. |
| 24 | MR. HOFFMAN: Okay. |
| 25 | COMMISSIONER JABER: Do you understand? |

| 16 | interconnection agreement so that there is no issue for |
| 17 | those items for this Commission to resolve. |
| 18 | MR. ROMANO: Those e-mails, clarifications were |
| 19 | sent, and I think the issues are resolved. The only |
| 20 | question that remains is that we had forwarded to |
| 21 | BellSouth contract language that actually we previously |
| 22 | exchanged term sheets that showed the language that would |
| 23 | be incorporated into the contract. We then forwarded |
| 24 | earlier this week language incorporated into the contract |
| 25 | itself for BellSouth to sign-off on so in the hopes that |
| | |

we could prevent it at this conference. But apparently
BellSouth is the person who would need to look at it is
out of the office.

So until that language, I guess, is signed off as it appears in the contract, I don't know that we can formally withdrawal these, although I think as Mr. Twomey indicated we've sent back and forth language confirming by e-mail that we're resolved these issue.

9 COMMISSIONER JABER: When you say you've 10 resolved the issue, are you suggesting that you would have 11 language as a stipulation to be included in the prehearing 12 order, or would you suggest that we remove the issue 13 entirely?

MR. ROMANO: I would like to have language included in the prehearing order, and that was why we had sent over the draft language to BellSouth, but unfortunately, it didn't work out that we could have it in place this morning.

19 COMMISSIONER JABER: All right. Let's do this: 20 By Monday close of business give to our Staff proposed 21 stipulation language to be included at the end of this 22 prehearing order. Alternatively, represent to our Staff 23 that the issue could be completely removed from the 24 prehearing order, but Monday close of business.

Now, I'm assuming if you all do not work it out

by Monday close of business, that you will need to revise
your positions to these issues because they currently
state that you've resolved the issue.

4 MR. TWOMEY: Commissioner, we have resolved the 5 issues. I think -- as I'm listening to Mike, I was unaware that they had proposed language to be included in 6 7 the prehearing order. I guess I'd have to think about that. We have certainly resolved a lot of other issues 8 9 too, and we will not include those in the prehearing 10 order. I think it would be more appropriate, once we have 11 signed off as Mike has requested that we do and only after 12 we have done that, that we simply withdraw the issues from 13 the arbitration.

14 COMMISSIONER JABER: Okay. Work with 15 Mr. Hoffman too. It is my intent that you either leave 16 the issue in and revise your positions, or you take the 17 issue out and submit proposed stipulation language, or you 18 remove the issue completely.

19 MR. TWOMEY: Okay. And, Mike, we can talk about 20 that either this afternoon or tomorrow, but I have no 21 doubt that the substantive issues have been resolved.

22 MR. ROMANO: I think that's right. I think we 23 were just trying to have something formalized for today 24 whether it went into the prehearing order as stipulated 25 language or whether it just permitted us to withdraw the
