

"Company"),

this Notice of Intent to Request Specified Confidential Classification.

1. On November 15, 2000, BellSouth Telecommunications, Inc. filed its direct testimony of the Georgetown Consulting Group, Jamshed K. Madden, Michael D. Dirmeier, and David C. Newton. Attached to that testimony are Exhibits 1 and 2, which contains Sprint Spectrum L.P. d/b/a (Sprint PCS) studies that include confidential business information that is considered proprietary to Sprint PCS. The cost studies provided to BellSouth was obtained from Sprint PCS an attachment to their Petition for Arbitration filed on June 23, 2000. BellSouth has signed a Protective Agreement with Sprint PCS. the Georgetown Consulting Group, Jamshed K. Madden, Michael D. Dirmeier, and David C. Newton as confidential.


