

Thank you for your comments regarding the rate case which is being processed for Tangerine Water Company, Inc. (Tangerine or utility). The staff assisted rate case process was developed by the Florida Legislature to assist customers of small water and wastewater utilities such as Tangerine. Instead of the utility having to retain outside accountants and engineers to process a rate case, Florida Public Service Commission (PSC) staff does the work and normally saves customers thousands of dollars in costs which would have been passed on to customers of the utility through rates.

As was mentioned at the customer meeting May 5th, the rates and percentage increases contained in the staff report prepared for the customer meeting are preliminary pending the outcome of updated costs, and further staff investigation which is now in process. The investigation will include an analysis of the utility's rate structure, and whether an inverted block rate structure (where the gallonage rate increases as consumption increases) is warranted. It is the goal of the State of Florida to conserve water since it is a precious and finite resource. Allowing a discount for utility customers who use larger quantities of water would be contrary to these goals.

The final recommendation to the Commission is scheduled to be filed June 17, 1999 for consideration by Commissioners at the June 29, 1999 Agenda Conference. You are welcome to attend the Agenda Conference and relay your concerns to the Commissioners. Once the Commissioners vote on staff's recommendation at Agenda, a Proposed Agency Action (PAA) Order will be prepared and issued within 20 days. Any substantially affected party may protest this PAA Order within a 21 day protest period after the Order is issued. If there is no protest of the PAA Order, the Order becomes final.

Thank you for your comments regarding the rate case which is being processed for Tangerine Water Company, Inc. (Tangerine or utility). The staff assisted rate case process was developed by the Florida Legislature to assist customers of small water and wastewater utilities such as Tangerine. Instead of the utility having to retain outside accountants and engineers to process a rate case, Florida Public Service Commission (PSC) staff does the work and normally saves customers thousands of dollars in costs which would have been passed on to customers of the utility through rates.

As was mentioned at the customer meeting May 5th, the rates and percentage increases contained in the staff report prepared for the customer meeting are preliminary pending the outcome of updated costs, and further staff investigation which is now in process. Section 367.081(2)(a), Florida Statutes, states:

"The commission shall, either upon request or upon its own motion, fix rates which are just, reasonable, compensatory, and not unfairly discriminatory. In every such proceeding, the commission shall consider the value and quality of the service and the cost of providing the service, which shall include, but not be limited to, debt interest; the requirements of the utility for working capital; maintenance, depreciation, tax, and operating expenses incurred in the operation of all property used and useful in the public service; and a fair return on the investment of the utility in property used and useful in the public service."

As you can see from above, the Commission is required to establish a fair return on the investment of the utility in property used and useful in the public service. Each year, the Commission establishes an authorized range of return on common equity for water and wastewater utilities under its jurisdiction. I am enclosing a copy of Commission Order PSC-98-0903-FOF-WS,

issued July 6, 1998, which establishes the current authorized range of return for water and wastewater utilities and explains the process involved in determining those ranges.

The PSC cannot guarantee the profitability of a utility. We can only provide the utility the opportunity to earn a fair rate of return based on costs set in the rate case. The fact is, based on annual reports submitted to the PSC, the majority of small Class C water and wastewater utilities in the State of Florida do not make a profit.

The final recommendation to the Commission is scheduled to be filed June 17, 1999 for consideration by Commissioners at the June 29, 1999 Agenda Conference. As was mentioned at the customer meeting May 5th, the rates and percentage increases contained in the staff report prepared for the customer meeting are preliminary pending the outcome of updated costs, and further staff investigation which is now in process. You were correct in your comments when you stated that the utility could have applied for rate increases since 1985. The PSC establishes an annual price index for water and wastewater utilities under its jurisdiction, which for 1999 is 1.21%. If the utility took advantage of the price indexes on an annual basis, the amount of increase in this staff assisted rate case would not be so high. However, since the utility chose not to apply for rate cases or price indexes since 1985, it has to absorb all losses incurred. The staff proposed rates are calculated on a going-forward basis. They do not make up for any losses suffered by the utility since 1985.


