Dear Mr. and Mrs. Richard Rubino:

Your letter of September 26, 2000, to former Chairman Garcia was referred to me for response. In your letter, you suggest that the LATA line be moved at the time a new area code is implemented in St. Johns, Flagler, and Volusia Counties. Unfortunately, however, this Commission does not set LATA boundaries; such changes are made solely by the Federal Communications Commission (FCC). Therefore, while this Commission can, and has, approved an area code change that includes Flagler and Volusia Counties, it cannot override the current LATA boundary line, as you suggest.

This Commission appreciates your situation, however, I believe that the results of the balloting and the findings in Order No. PSC-00-1811-FOF-TL resolve this matter.

Dear Mr. Garcia:

We are very saddened, although not surprised, at the outcome of the recent survey conducted by the PSC. While the majority of the occupants living in this area voted to keep the existing service, the remainder of us still have to deal with an unfair telephone system.

Most of these people living here have migrated from St. Aug. and Jacksonville, thus this service serves them well. We, on the other hand, moved 1000 ft. further north than we were, and must be subjected to paying a long distance charge for a local call to Palm Coast, which is still where we live.


It seems to me that at a time when new area codes are being implemented in St. John, Flagler, Volusia counties, it would be a perfect time to correct the error of this LATA line. A survey/vote would not have been necessary, and should not be necessary, to unite a county with the same area code. It seems that as far as the commission is concerned, the matter is closed. But it is not closed as far as I or others like me are concerned. We must, for however long we live in this area of Palm Coast, be subjected to this erroneous LATA line and the unfair long distance costs.

We do appreciate the concern and consideration that you and the PSC, including Mr. Ileri, have given to this matter, but it has not been resolved. Would the commission give consideration to implementing this new projected area code for the entire Flagler County, therefore over-riding the LATA line.

If this is impossible, I feel that special consideration should be given to those of us who endure this hardship, and a local/long distance calling plan be offered to us.
