On May 25, 2000, Valencia Area Condominium Association, Inc. (Valencia) filed a petition for declaratory statement regarding the applicability of Rule 25-6.049(5)(a)3, Florida Administrative Code. Valencia sought a declaratory statement from us indicating that Valencia A-1 is exempt from the individual metering requirement in Rule 25-6.049(5)(a)3, Florida Administrative Code, and was thus eligible for metering through a single master meter. On August 1, 2000, Valencia filed an Amended Petition for Declaratory Statement.

This filing must be completed within thirty (30) days after the issuance of this order, pursuant to Rule 9.110, Florida Rules of Appellate Procedure. The notice of appeal must be in the form specified in Rule 9.900(a), Florida Rules of Appellate Procedure.
