Since the Commissioners have not yet voted on this docket, you have three options.

- (1) Cancel the certificate voluntarily Pay all past due charges in full, pay the current year's RAF or provide a date certain that it will be paid (such as 30 days from the date of the Commission Order cancelling your certificate), and write a letter requesting cancellation.
