NOTICE is hereby given by the Florida Public Service Commission that the action discussed herein is preliminary in nature and will become final unless a person whose interests are substantially affected files a petition for a formal proceeding, pursuant to Rule 25-22.029, Florida Administrative Code.

Section 364.33, Florida Statutes, provides that a person may not acquire ownership or control of any telecommunications facility, or any extension thereof for the purpose of providing telecommunications services to the public, including the acquisition, transfer, or assignment of majority organizational control or controlling stock ownership, without prior approval from this Commission.

By letter dated January 22, 2001, TOTALink of Florida, LLC (TOTALink) and Utilicom Networks Holdings, LLC (Utilicom Networks) filed with this Commission an application for approval of pro forma corporate reorganization whereby TOTALink will become a wholly owned subsidiary of Utilicom Networks. TOTALink is the holder of Alternative Local Exchange Telecommunications Certificate No. 5276. TOTALink has stated that the transaction will be virtually transparent to its customers in Florida and it will not affect the services being provided. TOTALink has further stated that it will continue to operate under its existing certificated name and tariff on file with this Commission.

In accordance with our authority under Section 364.33, Florida Statutes, to approve the acquisition or transfer of majority organizational control or controlling stock ownership of a telecommunications company providing service in Florida, we have reviewed the Petition of TOTALink and Utilicom Networks, and find it appropriate to approve it. We have based our review and decision upon an analysis of the public's interest in efficient, reliable telecommunications service.

Based on the foregoing, it is,

ORDERED by the Florida Public Service Commission that TOTALink of Florida, LLC and Utilicom Networks Holdings, LLC's request for approval of pro forma corporate reorganization whereby TOTALink of Florida, LLC will become a wholly owned subsidiary of Utilicom Networks Holdings, LLC is hereby approved. It is further
