The above-referenced docket presents a series of revised Case Assignment and Scheduling Records (CASRs) here at the Commission, but not much else. The docket has its genesis in a 1994 Florida Water Services rate case.

There are assorted references to a proposed sale of the Tropical Isle wastewater system from Florida Water to a customer organization which would obviate the need for a restructured rate which was the original focus of this docket. However, the sale seems to be moving very slowly, if at all

It seems wasteful to undertake a hearing on the appropriate revenue requirement and restructuring of rates if this system is to be sold to a non-jurisdictional entity. On the other hand, to have the docket languishing here at the Commission unattended has its own cost. 0001
