BY THE COMMISSION:

SM 106 Ltd. (SM), holder of Pay Telephone Certificate (PATS) of Public Convenience and Necessity No. 5880, has requested the cancellation of PATS Certificate No. 5880. SM has complied with the provision of Rule 25-24.514(2), Florida Administrative Code, by providing adequate notice in writing of its request for cancellation of its PATS certificate and by submitting its Regulatory Assessment Fees (RAFs) for the year 2000. Accordingly, we find it appropriate to cancel PATS Certificate No. 5880, effective March 12, 2001. SM shall return to this Commission the Order granting authority to provide PATS services. The Commission is vested with jurisdiction over this matter pursuant to Section 364.335, Florida Statutes.

In addition, under Section 364.336, Florida Statutes, certificate holders must pay a minimum annual RAFs of \$50 if the certificate was active during any portion of the calendar year. A RAFs Return notice for the year 2001 will be mailed to SM. Neither the cancellation of its certificate nor the failure to receive a RAFs Return notice for the year 2001 shall relieve SM from its obligation to pay RAFs for the year 2001.

Based on the foregoing, it is

ORDERED by the Florida Public Service Commission that SM 106 Ltd.'s Certificate No. 5880 to provide Pay Telephone services is hereby canceled, effective March 12, 2001. It is further

ORDERED that SM 106 Ltd. shall return to this Commission the Order granting authority to provide Pay Telephone services and remit Regulatory Assessment Fees for the year 2001. It is further ORDERED that this Docket is closed.

The notice of appeal must be in the form specified in Rule 9.900(a), Florida Rules of Appellate Procedure.
