City-Link provides services in several other states, in addition to Florida. The operation is guite small in Florida and revenues so low that the assessed fee would be only \$12 for the year were it not for the \$50 minimum assessment. Last year the Commission accepted our settlement offer partially because we agreed to fix the problem for the future. Following the fine and settlement agreement of last year for a failure to timely pay regulatory assessment fees, City-Link instituted a new process to avoid such occurrence in the future by assigning me with the responsibility of notifying the company when regulatory assessment fees were due. I am regulatory contact and consultant to City-Link. I live in Colorado rather than Utah where their headquarters are located. My name, address, fax number, and e-mail are as contact for Florida PSC. The first I became aware of this year's failure to make payment on time was when I received the initial Commission order imposing the \$500 assessment. We immediately sent out the assessment which was due.

Subsequent investigation of why our process did not work found that where I am the regulatory contact, the Regulatory Assessment Fee Return Forms are in fact mailed to Corporate headquarters in Utah rather than to myself. I don't know what happened to it there. In order to once again fix the process and ensure timely payment to Florida PSC, I request that you change_ the mailing address to read:
