Dear Mr. Parrish: I was getting ready to write the recommendation to accept the company's \$500 settlement proposal when I double checked our RAF database and found that the 1999 RAF still has not been paid. When the company paid the \$550 on April 2, 2001, the \$50 was applied to the 2000 RAF, which was also past due. Then, you paid the \$9 past due penalty and interest on the 2000 RAF, still leaving the 1999 RAF unpaid.

Before I can accept your settlement offer, Florida City-Link must complete and pay the 1999 RAF return, which is attached. If the company owes the minimum, the total amount is \$71.00 (\$50.00 RAF, \$12.50 penalty, and \$8.50 interest).
