Dear Mr. Buys:

It was a pleasure talking with you this afternoon. The information you requested about our company and the carriers with whom we are working follows.

1st American Telecom, Inc. (1AT) is a distributor of debit prepaid phone cards. 1AT does not switch time itself, but purchases a product from a carrier that provides the network services (switches time). 1AT does not own nor does it lease switches from any other company. 1AT may contract with a carrier for a specific rate-deck (rates per minute to various countries) at a specific discount from retail. Customer Service responsibility is provided by the carrier. The carrier provides 1AT with PINS and 1AT prints the cards that it sells to its customers, who are the wholesale distributors, who in turn provide the product to the retail stores.

You had requested the carrier information on the "Dollar Saver" card 1AT had previously marketed. J.D. Services (JDS), Salt Lake City, Utah, was the original carrier and network services provider for this card. As part of our contract agreement with JDS, 1AT agreed to provide Customer Service for this card. The Dollar Saver project was too expensive for JDS unless 1AT agreed to provide Customer Service. This was the only time 1AT agreed to provide Customer Service. When JDS filed Chapter 7 bankruptcy on 9/25/01, we were able to have the Dollar Saver PINS ported over to Natel, LLC, Oklahoma City, Oklahoma, who became the new carrier until we discontinued selling the product.

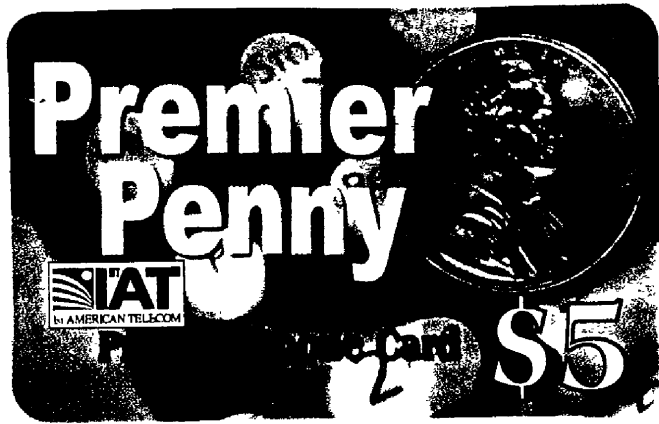
